### **Update from public land managers:**

Jason Guidry, DuPont State Park: Golden Warbler population is expanding. Land Revision- taking longer than initially thought, working on wrapping up the EIS. Met with State Forest Service in Marion indices are similar to 2016. Forest Festival day did well ~1,000 visitors. River ranger program removing many dams and collecting trash. Trails reroute and stream restoration is finished. Trails projects receiving a lot of funding. Additional funding is coming and they are now in the initial design phase for the Cradle. Red spruce restoration and stream restoration in Yellowstone Prong. Trail maintenance through winter on Graveyard fields.

Neal Wilcox, Gorges State Park: Same as last month

Michael Cheek- Headwaters State Park- Working on prescribed burns

Margot, Hemlock Restoration Initiative- New grant from the North Carolina Forest Service has allowed more workshops for the public. Latest one in Transylvania County was in Camp Carolina, the next one is in Buncombe County (volunteers needed). Will be working with Pisgah forest in November-December near Bent Creek to plant new research plots.

Torry, Conserving Carolina- Riverstewards Program now part of Conserving Carolina. November 2nd screening of Hidden Rivers- all proceeds go towards river stewards to fund river clean ups.

Jeff Parker, Soil & Water Conservation- Just finished more than 300 feet of stream restoration near Everett Rd.

Bart Renner, County Director- Support your local farmers!
